### 4.2. Most important symptoms and effects, both acute and delayed

#### Overview

Fumes from product can be unpleasant, may cause nausea, headache and irritating to eyes, skin, and respiratory tract.

#### POTENTIAL HEALTH EFFECTS

**Eye Contact:** May cause tearing, stinging, redness, irritation, and burns.

**Inhalation:** Irritating to respiratory tract. Prolonged or repeated breathing of very high vapor concentrations cause euphoria, excitation, and dizziness, headaches, nausea, and vomiting, abdominal pain, fatigue, muscular weakness. be absorbed through the skin and produce CNS symptoms. Single prolonged exposure is not likely to result in the product being absorbed through the skin in harmful amounts.

**Signs And Symptoms Of Exposure:** Eye irritation, respiratory irritation, drying and cracking of skin, dizziness, fatigue, headache, unconsciousness or asphyxiation.
